**WASHINGTON'S SELECTION PROCESS  
FOR  
DELEGATES TO THE 2012 NATIONAL  
PRESIDENTIAL NOMINATING CONVENTION**

The National Convention will be in Charlotte, NC Monday, September 3, 2012 through Thursday, September 6, 2012.

Our Democratic Governor, our two Democratic Senators, our five Democratic members of Congress, our members of the Democratic National Committee, and former Speaker Foley are all eligible to be delegates by virtue of the offices they hold or have held. Washington's Democrats will select their remaining delegates to that convention in two processes: (1) a system of caucuses will select our Congressional District delegates and alternates and (2) the members of the state central committee that represent legislative districts will select (a) pledged party leaders and elected officials and (b) at large delegates as well as alternates for both groups.

The caucus process begins at the precinct caucuses Sunday, April 15 at 1 pm. The 25th LDD plans to cluster those caucuses at a limited number of locations including the Boilermakers' Hall on South Hill, a location within Puyallup, and one or two others, but as of this writing, we have not completed those arrangements. We expect to announce the locations, precinct by precinct, at our March meeting. Precincts will generally elect one precinct delegate for every 75 votes the precinct cast for Obama-Biden in 2008. Those delegates will be allocated among the contending candidates and "no preference" in proportion to their support among the Democrats attending each precinct's caucus. Each preference's group in each precinct will elect their allocation of precinct delegates and alternates.

The elected precinct delegates and alternates will convene in Legislative District Caucuses thirteen days later at 10 am on Saturday, April 28, 2012. The relative preferences of the precinct delegates in attendance will control the allocation of the legislative district delegates. In other words, the 25<sup>th</sup> LDD's delegation will depend both upon who shows up at the precincts and who of the elected precinct delegates and alternates show up at the LDD caucus. Again, each preference will choose its slate of legislative district delegates.

The legislative district delegates—preference by preference—will then select national delegates at the congressional district caucuses on Sunday, May 24, 2012.

A person need not be a delegate at one caucus level to run to be a delegate at the next caucus level, but any person that wishes to be a national delegate or alternate must file a Declaration of Candidacy and be accepted by the campaign the person supports. The deadline for filing for congressional district delegates and alternates is May 4, 2012. The deadline for filing for Party Leaders, Elected Officials, and at large delegates and alternates is Friday May 25<sup>th</sup>.

The Rules Committee of the State Central Committee recommended and the State Central Committee initially concurred in using the precinct, legislative district, and congressional district boundaries in effect on November 8, 2011 because those boundaries are known and on-going organizations exist in the districts to set up and support the caucuses. Subsequently—and with no certainty that the redistricting process would yield timely, new maps of district boundaries—the State Central Committee reversed itself and called for the caucus process to use the new, yet-to-be-issued boundaries for legislative and congressional districts.

As of this writing on December 19, the Washington State Redistricting Commission has not issued new maps for either legislative districts or congressional districts. Because Pierce County will not have new precinct boundaries in time for the April precinct caucuses, the 25<sup>th</sup> LDD will use existing precinct boundaries for the caucuses. If the legislature adopts new maps before the caucuses, it is likely that the 25<sup>th</sup> will lose some territory because its population has grown so much. We will then need to work out arrangements for the precincts affected by the new boundaries. To that end, we have already written our neighboring LDs to suggest that we all take care of our current precincts through the precinct caucuses and then address the new boundaries. So far, we have received neither agreement nor rejection of this suggestion.

Regardless of which LD supports a precinct's caucus, the precinct level delegates elected at each precinct caucus will attend the LD caucus for the District in which they live according to the latest boundaries. In other words, if the legislature does adopt new district boundaries and if some but not all of a precinct, say Precinct 25-999, moves to the 29<sup>th</sup>, then the elected delegates that live in the new 29<sup>th</sup> will go to the 29<sup>th</sup> District's caucus and the others that still live in the 25<sup>th</sup> will go to ours, just as some of the 25<sup>th</sup> LDD's district level delegates went to the 6<sup>th</sup> CD, some to the 8<sup>th</sup> CD, and most to the 9<sup>th</sup> CD in 2008.

## BY-LAW RECOMMENDED CHANGES

Every two years, the E-Board reviews the 25<sup>th</sup> LDD's By-Laws to recommend changes for adoption by the members. To ensure adequate notice to the members, these changes must be mentioned on the agenda twice before coming up for a vote. You can review these proposals on our website.

The By-Laws set deadlines for submissions to the Chair to give the Chair and the E-Board time to consider them. The change in meeting night from Thursday to Monday showed that those deadlines implicitly assumed Thursdays and didn't work as well for Mondays. The suggested change in X.L. on page 9 should work better regardless of which night the Library is available.

We use the agenda to make sure that members can know what will and won't be up for action at any given meeting. This assures members the opportunity to participate in decisions they feel important and protects everyone from surprises. New language in X.C. emphasizes this point.

There are also some bigger issues the proposals seek to address.

Recent litigation has found the way the state has conducted elections for PCOs unconstitutional because non-Democrats could easily participate in the election of Democratic PCOs. Additionally the legislature has voted not to have a presidential primary in 2012. The combination means that unless the legislature provides a new process and that process meets the constitutional requirements, we'll have no way to elect new PCOs or even re-elect the ones we currently have. New language in IV.E-F. sets out a process for the 25<sup>th</sup> to elect PCOs and make appointments when vacancies arise. This language yields to the legislature for elections if the legislature does its job but provides a "Plan B" if they aren't able to agree.

Although its power to do so might be disputed, the State Central Committee has directed legislative district organizations to begin meeting within their new, 2012, redistricted, geographic boundaries within 30 days of adoption of the boundaries by the legislature. As boundaries change, we are likely to gain and lose territory and with it gain and lose PCOs. During 2012, some PCOs will have dual identities. The proposed language in IV.D. provides that during 2012, a PCO joining the 25<sup>th</sup> will be welcome and that a PCO eventually leaving the 25<sup>th</sup> can finish his or her term before departing. It only applies in years in which redistricting changes boundaries.

Finally, new language emphasizes that the 25<sup>th</sup> LDD is a means for us to exercise our own first amendment rights and not merely a franchise we obtain from the county or state party. The language is meant to give us a greater ability to say "No, thank you" if the state or county party passes something foolish or dangerous.
