
A Month in DC

I am currently in DC for a college class that will last for three weeks. After the first week, it is clear that this is an excellent opportunity. We have met with various groups that are involved with the political process, and have many more meetings scheduled. This is a non-traditional class, where most of our class time involves meeting with people who influence the government rather than lecture from our professors.

One group that we met with last week was Public Citizen. Founded in 1971 by Ralph Nader, Public Citizen works to protect and expand the framework of representative government. One of the projects that they are currently focusing on is reacting to the *Citizens United* Supreme Court decision that allowed unlimited corporate spending in our elections. The staff member with Public Citizen that we spoke with said that when the *Citizens United* decision was handed down he did not believe that we would be able to get a constitutional amendment stating that corporations do not have the rights guaranteed to people by the Constitution. However, in the past few years momentum has built to the point where an amendment is actually a possibility. I agree with his assessment of the situation, and am looking forward to working to get such an amendment passed.

We also met with a representative from the Center for Economic and Policy Research, or CEPR. This group investigates the connections between public policy and how the economy works (or doesn't work) for the working class. The bulk of his presentation centered on a graph showing the percentage of total annual income earned by the top 1%. This figure decreased from the 1930s to the 1970s, before beginning to increase leading into the '80s. Despite being essentially unchanged through the '90s, it is now accelerating upward faster than at any other time in the last century. While there were many government policies that affect this figure in one way or another, the representative from CEPR pointed out that the percentage of income going to the top 1% is can be explained almost entirely by the power of the labor movement: when labor is strong, working people make more money, but when labor is weak, working people make less money. The only way to put our country back in a safe financial position is to strengthen the labor movement because the working person is the backbone of America.
